

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 559.9 tCO₂e by 2028. This is a reduction of 18.5 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline and the measures will be in effect when performing the contract. The carbon emission reduction achieved by these schemes equate to 82.4 tCO₂e, a 12% reduction against the 2023 baseline.

- Reduced the number of company cars
- Switched to public transport for business travel where possible

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Last 2 company cars will be returned to supplier and staff will use public transport where possible
- Take steps to increase office energy efficiency
- Investigate using more sustainable packaging and reduce amount of packaging used
- Engage with delivery partners to change to electric transport
- Update travel policy with low carbon emissions guidelines
